LOSS of the EXEMPTION for SITE IMPROVEMENTS

The exemption for the site improvements provided in section 63-602W(4), Idaho Code, shall be lost **when construction of any buildings or structural components of buildings is begun** or when title to the land is conveyed from the land developer at any time following the installation of the site improvements.

- a. Conveyance. **Any change in ownership** conveying title to land by deed or court order shall be considered a conveyance and result in loss of exemption
- b. Timing. Site improvements losing this exemption shall be subject to assessment and taxation in accordance with the change of status provision of section 63-602Y, Idaho Code.
